

Transcripts Available Electronically

You may have noticed that you can now access an electronic copy of your transcripts available on the Education page in your Registry account. Since last May, The Registry has been scanning and uploading the transcripts for new and renewing members. Members

can access their transcripts and download a copy at any time. The Registry anticipates finishing the work of uploading everyone's transcripts in 2019.

E-Certificates Coming Soon!

Starting **October 1, 2018**, The Registry will make Registry certificates available electronically for all current members. Log in to your Registry account and access your e-certificate anytime on your Reports page. You will be able to download your certificate immediately after The Registry finishes processing your application. No more waiting for your certificate in the mail!

For those who still want to receive their certificates in the mail, The Registry will print and mail your certificate for a processing fee upon request.

The Registry has developed an app for you to access your Registry Card whenever you want. Download the app for free and have your card with you wherever you go. It's one less thing to think about.
