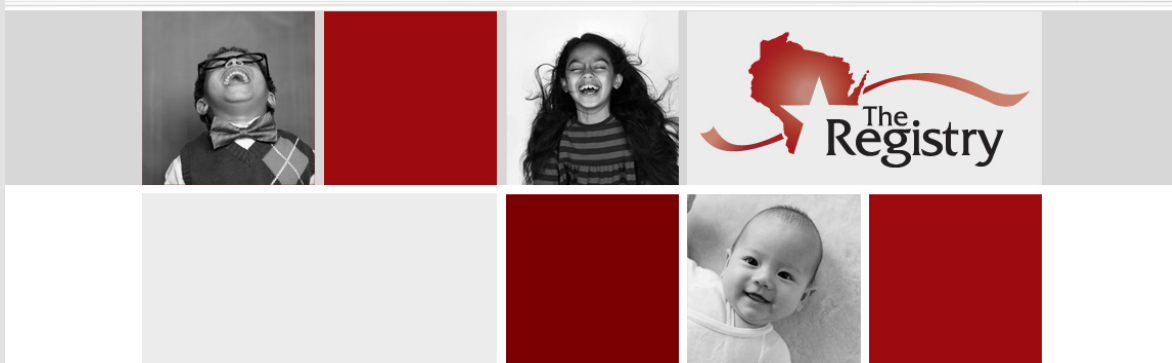

Importance of Listing Your Wages

Ever wonder why The Registry asks about your wages when you submit information about employment? Find out how this information can make a big difference in the childhood care and education field!

Compensation Gap

"In Wisconsin, the average child care worker earns \$10.33 an hour.... Yet child care teachers are, on average, more educated than the typical Wisconsin worker."

These words about compensation appeared in an [article](#) on the Wisconsin Public Radio website this past spring. Disappointing to say the least, but it comes to no surprise that this issue is an important hurdle in the childhood care and education field and must be addressed.


Though you may not know it, The Registry is working along with many agencies across the state and nation to close this gap in compensation.

How The Registry helps


Have you ever wondered why you are asked to list information about your wages when you enter your employment history in The Registry? Wage information is shared anonymously at the state and national levels by The Registry. This data helps lawmakers and advocates better understand the gap in compensation in our field to inform public policy. Though change may seem slow, our field has come a long way over the years.

How can I help?

By listing information about your wages, you are helping to inform public policy and make a difference. If you would like to share information about your wages, you can log in to your Registry Profile and see if your wages are listed. Click on the Employment tab and follow the directions below:

1. If you haven't previously shared your wages, you will see **N/A** listed under **WAGE**. You may edit this at any time and enter your wages. This data will be shared anonymously.
2. To add your wages or any employment related to the field that isn't listed in your employment history, click on the **EDIT EMPLOYMENT** button to get started. You will be asked questions about your employment such as the title of your position, the ages you primarily work with, and your wages (see image below).
